**RAE Class:** Dogs entered in this class must be entered in both AB & EB. Once the limit has been reached in either of these classes the RAE class will be considered closed, and any subsequent entries for this class will be unacceptable in their entirety. Entry fees must be paid for both classes. Transfers [move ups] are permitted by giving notice to the Trial Secretary no later than one-half hour before Rally judging begins.

**RACH Class:** Dogs entered in this class must be entered in Advanced B, Excellent B. and Masters, Entry fees must be paid for all 3 classes. . Once the limit has been reached in any of these classes the RAE class will be considered closed, and any subsequent entries for this class will be unacceptable in their entirety. Transfers allowed as above.

## NOTICE TO EXHIBITORS (All Shows)

**CONDITIONAL, UNSIGNED, INCOMPLETE, TELEPHONE, OR ELECTRONIC** entries cannot be accepted. ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC entry forms are NOT ACCEPTABLE. THE CLUB AND ITS SHOW SECRETARY ASSUME NO RESPONSIBILITY for wrong or incomplete information given on the entry blank by the owner or agent of the owner. This Club and its Show Secretary assume no responsibility for the owner or owner's agent entering a dog twice or in a class for which the dog is ineligible to compete.

**ENTRY FEES** will not be refunded in event of errors or cancellation of entries after the published closing date, nor in the event that a dog is absent, disqualified, sick, lame, or excused by the Veterinarian or Judge or barred from competition by the Bench Show Committee, or because the dog is ineligible to compete because it is incorrectly entered. Extreme weather conditions, such as but not limited to snowstorms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, judges, exhibitors and spectators. The wellbeing of dogs and participants is of paramount importance and in the event, it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

## INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
